PROTESTS: RRS 61.1 (A) IS CHANGED by ADDING THE FOLLOWING: "a Boat intending to file a protest shall additionally inform the race committee finishing line boat upon finishing or, if unable to finish, at the first reasonable opportunity, and shall include the sail number (s) or otherwise identify the boat(s) involved in the incident." Failure to do so will make the protest invalid.

SAFETY: It is each competitor's exclusive and individual responsibility to decide whether or not to race or continue racing and to otherwise provide for his or her own personal safety. Competitors are reminded that all federal and state safety regulations should be observed.
