1. RULES

The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).

2. ELIGIBILITY AND ENTRY

2.1 The regatta is open to all PHRF rated boats and all class-legal One-Design boats.

2.2 Fleets will be determined after registration.

2.3 Expected fleets are: Spinnaker; Non-Spinnaker; and One-Design.

2.4 Eligible boats may enter by submitting the entry form and the required fees.

3. FEES

The entry fee is \$50.00 per boat. The fee includes one (1) ticket for the Saturday Pirates Party.

6. THE COURSES

6.1 The racing area will be located east of FWYC on Choctawhatchee Bay.

6.2 The courses will be a Windward/Leeward with dropped marks.

7. SCORING

7.1 The Low Point System of Appendix A will apply.

7.2 Two (2) races are required to be completed to constitute a regatta.

7.3 When five (5) races have been completed, a boat's series score will be the total of her race scores excluding her worst score. This changes Rule A2.

8. PRIZES

Captain Billy Bowlegs and his Krewe will present awards after the last race.
