HEREAFTER) AND ALL ACTIONS RELATED TO.**

Acknowledges my responsibilities in participating in this event, for my decisions to start or continue in this event and to make certain that my boat, equipment and crew are seaworthy for the conditions, which may be encountered during my participation.

Acknowledges that maritime tradition and law provide that a vessel's Captain is ultimately and solely responsible for the welfare of ship and crew and must possess the competencies of prudent seamanship and independent action necessary to provide for the same.
