2021 DOUBLE HANDED REGATTA

1. RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).

2. ELIGIBILITY

- 2.1 The regatta is open to FWYC Member boats with PHRF or Portsmouth rating.
2.2 Boats without a rating will be assigned one based on US Sailing and GYA data.
2.3 PHRF fleets: A (less than 100); B (101 to 150); C (151 and above); M (Multihull).
2.4 Portsmouth Fleet: PD (Portsmouth rated dinghies).
2.5 A minimum of three (3) boats will constitute a fleet.
2.6 All boats will have a maximum of two sailors on board at all times.

3. ENTRY

4. FEES

- 4.1 The entry fee is \$10.00 per boat.

5. SCHEDULE

- 5.1 Race Day Events:
Check-In: 10:00 AM – 11:00 AM
Skippers Meeting: 11:05 AM
First Warning: 11:55 AM

6. SAILING INSTRUCTIONS

- 6.1 The sailing instructions will be available electronically.

7. THE COURSES

- 7.1 The racing area will be located on the waters of the Choctawhatchee Bay.
7.2 Courses will be short to medium distance utilizing Government, Club, and/or temporary marks.
7.3 Courses will be available electronically and posted on the FWYC notice board prior to 11:00am, May 22, 2021.

8. RADIO COMMUNICATION

- 8.1 The race committee will broadcast/monitor VHF channel 72.
8.2 Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

9. PRIZES

- 9.1 Prizes will be awarded to the boats with the highest scores in each fleet.

10. DISCLAIMER OF LIABILITY

- 10.1 Competitors participate in the regatta entirely at their own risk. See RRS Rule 4, Decision to Race. The Fort Walton Yacht Club will not accept any responsibility for material damage or personal injury, or death sustained in conjunction with or prior to, during, or after the regatta.
